Available Funding & Fees

15hrs Universal Funding for all children aged 3 & 4 yrs

The term after all children turn 3yrs entitles them to receive 15hrs of funded early years education.

Additional 15hrs Funding for Working Parents of children aged 3 & 4 yrs

For working parents of 3 and 4-year-old children, parents can claim a further 15hrs of funded childcare or split care with another childcare setting. Apply for funding via <https://beststartinlife.gov.uk> - places will only be offered once we have verified the funding code issued by HMRC

Funding for Disadvantaged 2yrs-olds (FRAS)*

Some two-year-olds are entitled to 15hrs of funded childcare, families are usually informed by their local authority the term prior to the child's 2nd birthday, eligible families will receive a funding code which they must give to us prior to a place being offered.

Upto 30hrs Funding for Working Parents of children aged 18mths to 2yrs

For working parents of children aged 18 months plus, parents can claim up to 30hrs funded childcare. Applications for funding should be made via <https://beststartinlife.gov.uk> and places will only be offered once we have verified the funding code issued by HMRC

The awarding of all Early Years Funding is dependent on parent/guardians completing a Parent Declaration Form (PDF), we require a copy of your child's birth certificate

Kerswell Nursery are not responsible for renewing eligibility codes, parents that loose funding are liable to meet the full costs of fees
